Presidents Report: Cari Mohler

- 1. Membership to Boosters and PTSA will now be combined as Wildcat Club.
 - a. Some families have already registered individually for Boosters, prior to the new membership links being live.
 - b. Cari will send an email to people who have already purchased Boosters membership or Wildcat membership to reregister.
 - c. All memberships will be purchased through GoFan.
 - d. Links to each of these membership options must be added to the Boosters website.
- 2. New Membership Options:
 - a. Wildcat Club Only, without game passes
 - b. Annual Membership 1, 2, 4 people
 - c. Seasonal Memberships:
 - i. Fall Only, 1, 2, 4 people
 - ii. Winter Only 1, 2, 4 people
 - iii. Spring Only 1, 2, 4 people
- 3. Passes are good for entrance into all home games up until DVC tournaments.
- 4. Wild Cat Kickoff this Friday 8/18 set up at 3pm actual event is from 4pm 6pm.
 - a. Food trucks and dunk tanks will be set up.

<u>Treasurer/Joe Scardina:</u>

- 1. Team Wish Lists were turned into Joe.
- 2. We discussed the requests and tried to keep distributions equitable among all teams, over the past 2 years. We may have less money to give back to the teams, due to the 50% profit sharing from concessions.
- 3. The Wish List budget was approved.
- 4. Joe provided tax exempt form, for any expenses.

Concessions/ Cari Mohler:

- 1. Concessions Team Fundraising:
 - a. Coaches were sent an email with instructions for teams to sign up to work a football game at concessions (optional).
 - b. We have teams/clubs signed up for 5 of 12 games.
 - c. Each team/club must provide 8 adults and 8 students to work a JV or Varsity game.
 - d. 25% of the profit will be shared with each team that volunteers to work a game.
 - e. Students cannot handle money.
 - f. Games that do not have a team/club working will be staffed via the regular process (Sign up Genie requesting volunteers).
 - g. Checks will be cut to coaches at end of season.
- 2. Stocking Concessions:
 - a. Cari will order GFS and Sams Club items to be delivered and will need help unloading and stocking.
- 3. Simplified Menu:
 - a. Hot food: Cheeseburgers, Hamburgers, Hotdogs, and Old Town Pizza
 - b. Snacks: Pretzels with cheese, Nachos with cheese, Chips, Popcorn
 - c. Drinks: 3 colors of Gatorade, water, pepsi, diet pepsi, sprite, hot chocolate
 - d. Candy: Kit Kat, Twix, M&Ms, sour candy
- 4. Pricing was determined and Carrie Foley will order a new Concessions pricing sign.
- 5. Wildcat Trailer will be set up to sell bottled water only,
- 6. Health inspection is complete and we passed.
 - a. Need a kit to clean up vomit, sanitizer for the sinks, and bathroom hand washing signs.
